BOARD OF TRUSTEES

From painting bathrooms to line-by-line analysis of the church's budget, your Board of Trustees continued to provide a wide range of service to Westminster in 2008. Here are the highlights:

*Completion of the \$65,000 Stained Glass Window Preservation campaign. This successful fundraising effort combined the generosity of our members and friends, the church's children through their "stained glass" candleholder sales, estate gifts and a grant from the local historic preservation society. Our beautiful west window is secure for years to come!

*Creation of a structure for our Planned Giving efforts. With the help of church staff, the Trustees prepared a Planned Giving brochure which explains options for making an estate gift to Westminster. A local estate planning attorney then provided a free informational presentation to the congregation on this same topic. A similar presentation will be provided annually. We also established the "Gamble Society", in honor of pioneering church member Mary T. Gamble, to recognize those who include gifts to Westminster in their estate plans. With deep gratitude we remember the generosity of Mary Ellen

Pring, Mary Louise Howard and Bob Small, whose estates gifted Westminster with over \$43,000 in 2008.

*Focus on increasing revenues. In addition to keeping an eye on expense reduction, the Trustees convened the Ad Hoc Revenue committee which identified a number of income-generating initiatives for Westminster. What quickly became apparent was that a number of these initiatives required additional church policies and participation to be successful. Taking a step back, the Trustees refocused to:

- revise and adopt new kitchen use policies, including detailed instructions for using our kitchen equipment; (Thanks Robin!)
- revise our overall facilities rental policies and rental rates;
- create a new Facilities Rental brochure to advertise what Westminster has to offer;
- establish the "Event Hosts" program to provide trained Westminster volunteers to oversee the use of our building by outside groups.

*Maintenance of our beloved church home. After costly and time-consuming repairs, our commercial dishwasher now meets health code standards! Repairs on the air blower were completed, a work party tended to the landscaping, an outside safety rail and safety glass for the 2nd floor stained glass window were both installed, and yes, the Trustees painted the main floor and Social Hall bathrooms. Guidance for the ongoing "care and keeping" of our church home was provided by the Trustees' Ad Hoc House Committee which made and implemented a number of recommendations from cleaning and sorting and junk removal to rearranging furniture to looking at the various ways we can make our church home a place of welcome.

*Last, but always present, the Trustees spent a substantial portion of this year overseeing the church's finances, including finalizing both the 2008 and 2009 budgets. This "double budget" year was the result of the Church Council's adoption of the Trustees' recommendation that we move the budgeting process up by several months. As a result, the 2009 budget was adopted in late 2008, rather than two months into the next fiscal year, as has been our practice. This change was especially important this year because of the proposed and, ultimately, adopted budget recommendations which included a reduction of staff time. The earlier budget cycle provided more time for discussion with affected staff and consideration by the church leadership and congregation as a whole. Although never an easy recommendation to make, the cost cutting measures adopted in the 2009 budget are a meaningful step forward in addressing our ongoing budget deficit. The combination of expense reduction with the congregation's thus far positive response to a request for increased pledging translates to a 2009 estimated deficit of \$63,237. *This means our 2009 proposed deficit is less than* ^{1/2} of the \$114,203 deficit we faced in 2008. The 2009 budget draws us significantly closer to our goal of aligning income with expenses and achieving long-term sustainability.

Paintbrushes and calculators in hand, the Board of Trustees looks forward to another year of service to Westminster!

ASSISTANT PASTOR

The cover on my desk calendar and planning book reads "Immerse Yourself!" It's the theme for the upcoming UCC General Synod 27 that I will be attending. "Immerse Yourself!" also describes the life I share with you here, and it's at the core of my call as a child of God to serve.

In looking back at 2008, one thing is clear: Westminster is a gift of God ... to those who come to the church and to those we serve in the community. On the inside, we have prayed and worked hard to create a welcome and safe space for all. Weekly we continue to experience an intimate "early" worship service, accompanied by Paul Grove on guitar or Susan Windham on piano, and sharing communion every week. The Nurture Board has created a CAFÉ (Children, Adult and Family Enrichment) Hour during which time all are welcome to share in a time of fellowship or participate in our Adult Discussion Group. Our youngest children have access to the attended Playroom/Nursery and those 5 to 12 have Sunday school, now using a curriculum designed to engage the lectionary text with questions and thoughts that fit a forward-thinking people of faith. The midweek group Questioning Believers shared in a simultaneous study with the Adult Discussion Group using Diana Butler Bass's *Christianity for the Rest of Us: How the neighborhood church is transforming the faith.* The Questioning Believers moved forward with Eric Elnes' *The Phoenix Affirmations*, and the Adult Discussion Group picked up on a series of conversations about "Our Faith, Our Vote" and then the Eight Points of Progressive Christianity.

Our Board of Outreach was creative in their efforts to engage fun ways to serve and love our neighbors. Westminster has increased giving through the UCC offerings as well as to our local beneficiaries (Second Harvest Food Bank, Meals on Wheels, SNAP, Life Feed, and the Pastors' Emergency Fund). Our understanding of "neighbor" has explored new opportunities still unfolding with local and global ministries.

On the outside, my presence in the community models that Westminster is truly an "out there" kind of place. We are valued and respected for our service: Financial assistance with prescriptions; official ID or other needed documents; transportation aid for work or family emergencies; funds to help with utilities; assistance with moving people to more permanent housing; and referrals to other suitable community agencies. It's common for me to speak with five or more people each week who need to know they are not alone in what is often an inhospitable world. On the last Saturday of most months a team serves a free lunch to over 100 neighbors and friends, practicing our hospitality and welcoming skills. In my role as an "out" pastor, I support those who suffer all forms of abuse by those who are less accepting of God's creative differences.

Westminster is becoming known as a safe place for ALL as <u>we</u> tell our stories, provide compassion and invite others to do the same. Last June we hosted the Interdenominational Pride Worship Service as a part of Spokane's Gay Pride celebration—12 other clergy joined Pastor Andy and me in welcoming ALL God's children to worship and to communion at the Table to which ALL are invited. In October we began a partnership with The Inland Northwest LGBT Center, hosting a monthly potluck for all ages in our Social Hall. In November we hosted a memorial service as a part of the Spokane Homeless Coalition's participation in National Homelessness and Hunger Awareness Week.

We have a distinctive legacy to celebrate, and our future is unfolding before us. Our life together is about our faithfulness, about the relationships we share here with each other and with the still-speaking God. Let us continue to find ways to talk with each other about sacred texts and what they mean for us. Let us listen to each other and share our ideas about creating welcome for all. Let us explore new ways of taking our stories from the inside to the outside, inviting others to come and experience the hope we find as we gather to serve each other, our neighbors, our community and our world. Remember God's grace in our lives and in this place. Let us immerse ourselves in the God-life! Praying peace, serving still, Pastor Marj Johnston

FINANCIAL SECRETARY/ OFFICE MANAGER

2008 was quite a year. Record snow at both the beginning and the end led to a number of unavoidable repairs to the roof and now to the need for a new reader board on Washington Street. Keeping up with snow removal and making the block safe for our congregants and neighbors was a chore ably handled by John Koons and James Jones.

We completed stage 2 of the electrical upgrade which included retrofitting and replacing all fluorescent lights and fixtures to be more energy efficient in hallways and church offices, as well as installing new outlets and fixtures in the bathrooms and in the SACC offices.

With the budget a chief concern, we have tried very hard not only to stay within our financial limits but also to decrease spending wherever we could. It has been an honor to work with our two pastors this year as we worked as a team to help shape a realistic budget, and to prepare for the challenge of Pastor Andy's sabbatical in the coming spring. It was the realization of a long-term goal to shift the budget approval process to earlier in the fall, so that we could begin January with a confirmed budget for the year, and I appreciate the hard work of all who made that happen.

I also want to thank everyone who helped me this year with all of the extra office work our church projects bring. I couldn't do it without you. Special thanks go to Karen Wilson-Bell who has volunteered in the office throughout the year, helping to answer phones and to assist with many large projects including updating the church membership records, working on the Tree of Sharing, and helping get the newsletter ready for mailing. I also want to specifically thank Hal French, who comes by every week to take the bank deposit, every month to take the newsletter to the processing center, and also to help out with whatever needs doing.

NURTURE BOARD

2008 was a busy year for the Nurture Board. We explored a lot. We discussed a lot. We considered a lot. The outcomes included establishment of the CAFÉ Hour. CAFÉ—short for "Children, Adult and Family Enrichment"—Hour was an outcome of substantial exploration into Sunday School as it currently exists at Westminster, for our children and our adults. A "pilot program" for the children's education was adopted, allowing for a between-the-services enrichment session for children so that they could be more incorporated into the church services. For families concerned about their children's ability to manage the 10:30 service due to temperament or attention challenges, the playroom/nursery remained available as well as an added activity leader (Jessie Vignali) who assisted with crafts and activities in the Social Hall.

Substantial research went into reviewing curricula at all levels. *Seasons of the Spirit (SOS)* was accepted as appropriate for the children's segment of the CAFÉ Hour. Based on the lectionary, the hope was that the lessons for the children would parallel the focus of worship services, allowing parents and our young folks to share conversations and ideas. We shared an *SOS* training session with Veradale UCC in late summer.

The adult discussion groups/forums were led by a number of individuals. Dan and Elsa Distelhorst and others helped facilitate conversations using Diana Butler Bass's *Christianity for the Rest of Us: How a neighborhood church is transforming the faith* for the first five months of the year. Nick CastroLang and Jim CastroLang facilitated discussions about the relationship of politics and faith using some materials from the UCC "Our Faith, Our Vote." Both Pastor Andy and Pastor Marj shared in conversations about Eight Points of Progressive Christianity, as did Jon Louis and Jim CastroLang. And the Wednesday night group—Questioning Believers—studied *Christianity for the Rest of Us* simultaneously with the Sunday Adult Discussion Group, followed by *The Phoenix Affirmations* in the Fall.

The adult program adopted the acronym TAGS (Talking About God Stuff) for a casual series through the summer and facilitators used movie clips, a favorite song, a magazine article, and a word from a book as topics of conversation.

Westminster's Eighth Annual Family Camp at N-Sid-Sen on Lake Coeur d'Alene grew with a total of 62 people participating in most or all of the weekend. This retreat of rest, relaxation, craft projects, fellowship and campfires is a vital part of our annual church family activity.

Areas continuing to be under discussion include addressing the need for a middler and/or youth group, intergenerational activities, Pastor Andy's upcoming sabbatical, and Vacation Bible School. Thank you to all those folks taking responsibility for carrying out the many functions of the Nurture Board – to Janet Ruehl for tirelessly keeping the Coffee Hour alive and well; to all the volunteers taking minutes at meetings and representing the board at Church Council meetings; and to the parents and teachers supporting the children's study in *Seasons of the Spirit*.

We continue to look for additional folks to facilitate Adult Discussion Groups, teach our young people in Sunday school, and join the current Board members in carrying out these important tasks. Thank you to the current Board—Cindi Abbott, Dan Distelhorst, Kathy Ellsworth, Molly Hilby, Janet Ruehl, Teresa Schock, and Marcus Soper—and to Pastor Marj Johnston for guidance and support.

OUTREACH BOARD

Under the expert and enthusiastic direction of Pastor Marj Johnston, the Outreach Board remained active this year, supporting many programs within the church and reaching out to the local and wider community. The Board also undertook some long range and budget planning in order to clarify and strengthen its mission to Westminster and the wider community.

The Manna Concert was once again coordinated by Marian Thackray. The amount raised was \$\$2525, down from last year. Second Harvest Food Bank and Meals on Wheels each received a check for \$ 1262.50.

Westminster continued to support Crop Walk. Chuck Fisk again led the effort. This year, Veradale United Church of Christ issued a challenge to Wesminster to raise \$2500 for the walk. While soundly tromped by Veradale, \$1425.20 was raised--an increase from 2007.

Chuck also continued to coordinate Westminster's participation in Meals on Wheels. During his absence in the summer, Marian and Keith Thackray filled in for him. All did an outstanding job. Shelby Rothstrom designed a new sign-up poster for the Narthex which made it easier for volunteers to sign up. A number of new people participated in delivering meals. Volunteers are always needed. Please contact Chuck if you can help with deliveries. Thank you to all who helped deliver meals during this past year.

Coordinated ably by Lou McKee, nine people made a mission trip to Felsorakos in April. The people of the village were generous and warm in their welcome of the travelers. It was a trip of a lifetime and one that will never be forgotten by those who went. While there, the picture books collected from the congregation were presented to the elementary school. A check for \$2000 and many supplies were presented to the Unitarian Church and its pastor Josef to be used for a guest house

for visitors to the village. The guest house is intended to raise badly needed funds for the village. Although the European Union has approved a grant to improve the water supply of the village, the Romanian government continues to drag its heels and the prospect of improvement of the water system remains shaky. In December, the Church Council approved a new document of intent submitted by the Friends of Felsorakos.

Special offerings to assist programs of the national United Church of Christ were held though out the year. They were One Great Hour of Sharing, Neighbors in Need, Strengthen the Church, and the Christmas Offering. Additional offerings benefited the Second Harvest Food Bank, the Manna Concert, Life Feed, and the Pastors' Fund. A special drive to collect socks for Crosswalk was conducted by the Board in January. A goal has been set to raise more socks than last year when 234 pairs were collected. The Outreach Board also supported "World Vision Experience: AIDS" sponsored by First Presbyterian Church in May.

The Outreach Board and Westminster again helped coordinate the annual Tree of Sharing. Many church members staffed the table at Riverpark Square. Again, approximately 6500 people benefited from the generosity of Spokane's citizens.

Dispersal of \$5436.41 in interest from the Stevenson Fund was completed in October. The money went to the Pastors' Emergency Fund, the Outreach Contingency Fund and 6 organizations in Spokane and 1 in Seattle. Those agencies were: The Children's Alliance, Hope House, the Interfaith Hospitality Network, Meals on Wheels, The Second Harvest Food Bank, City Gate and the Women's & Children's Free Restaurant.

Joe Karmarz and Karen Dashiell from the Interfaith Hospitality Network made a presentation to the Board in September. Interfaith Hospitality provides assistance and over night housing to homeless families in Spokane. The Outreach Board decided to participate in the program by providing a meal and volunteering for an evening at the Friends Church. The Board wanted to have a true understanding of what is involved in supporting a church that provides over-night lodging for Network families before sponsoring it as a church involvement. Unfortunately, a record-breaking snowstorm forced the Board to cancel its involvement. It plans to participate the next time the Friends church is scheduled to host families for a meal and overnight.

The Board served Coffee Hours April, October and January.

Thank you also to the hard work and efforts of Board members Chuck Fisk, Lou McKee, Marian Thackray and Shelby Rothstrom and Gayla Schilling. It is the opinion of this writer that the Outreach Board has grown in understanding of its mission of reaching out to our neighbors in Spokane, Washington and our world. Special thanks, appreciation, and blessings to Pastor Marj for her inspiration and direction throughout the year.

SECOND CENTURY ENDOWMENT FUND

The Second Century Endowment Fund was chartered in 1978 with the mission of building an endowment that would provide a steady income stream to the church through sound financial practices. The Trustees of Westminster appoint three individuals to oversee the funds investments. Members of the committee are Bryan Olson, Breean Beggs and Gene Fitzpatrick, Chair.

The committee meets on a regular basis to review the performance of the portfolio. Assisting the committee is Robin McLain and the Wealth Management Department of Washington Trust Bank. The investment portfolio is structured to generate income without risking the asset base. The income earned each year is remitted to the church for the next years operating budget.

2008 was a troubled year in the area of finance. The value of the portfolio declined along with the market. The change in the market value is as follows:

The decline in the financial markets in 2008 will have an impact on future earnings of the fund as companies and government agencies work to regain a solid financial footing.

In 2008 the committee worked on an Investment Policy. This policy will assist the current and future members of the committee and the church in managing the portfolio. The topic of Socially Responsible Investing was debated for an extended period and input from other members of the church and our advisor Washington Trust Bank was sought. The policy was put into final form late in 2008. The policy reflects the goals of the trustees to have a safe & secure investments that meet the needs of the church and the community we serve.

MUSIC & ARTS COMMITTEE

In our regular monthly meetings (excepting August) the current M&A committee has met since April 2008 and covered the following topics:

- □ We discussed and advocated keeping the budget for section leaders for the choir.
- □ We discussed the need for a long-term campaign to keep the organ in good repair. This becomes increasingly important as the organ is nearing the point in its life where a total overhaul is normal maintenance.
- □ We discussed and arranged providing alternate music for the days that Scot will not be available (due to budget cuts) for organ music and choir direction. We created a core musical ensemble that will also pull in other musicians for special music as well as provide the hymn music.
- □ We discussed ideas about alternate visual treatments for the chancel area.
- □ We discussed and supported the goals of the Nine Directions in our church.
- □ We initiated a procedure of encouraging interested volunteers to seasonally decorate the chancel area. This includes training and helping them develop creative ideas.

We increased the committee membership of Music and Arts to six plus two staff members. Respectfully submitted, Carlos Alden

PERSONNEL COMMITTEE

Under the leadership of Breean Beggs, the Personnel Committee completed its review of the staff reviews conducted by Pastor Andy and Alan Mackay along with the Committee's own review of Pastor Andy. The Personnel Committee made a list of recommendations for church action. The Committee and the church also completed all but one of its recommendations from 2007. The recommendation of forming a Pastor Relations Committee was tabled as the new Personnel Committee and Pastor Andy thought it was a conflict of interest for members of the church to serve on such a committee. Pastor Andy has sought support and guidance from a neutral advisor outside of the church

With the resignation of Eugene Johnson and Breean Beggs, Tim Henkel and Jon Louis became part of the Personnel Committee in the fall of 2008.

The focus of the committee since the fall has been the restructure of the church staff. The Trustees with the concurrence of the Personnel Committee recommended to the church that the hours of the support staff be cut in order to bring the church budget more into balance. Each staff member was met with before the proposal was taken to the Church Council. With the passing of the church budget in November, this recommendation became a reality. The following cuts were made:

- Office Manager and Finance Secretary Robin McLain's hours were moved from 30 to 20 per week.
- Caretaker John Koons' hours were reduced from 40 to 30 per week.
- Choir Director/Organist Scot Stout's hours were changed from 20 to 15 per week.
- Publications Secretary Sarah Hopkins' hours were not reduced; however she is expected to keep her work within the prescribed \$5000 per year.

With the change in the hours of much of the staff, job descriptions were rewritten.

The recommendations made by the Personnel Committee after staff and Pastor reviews were tabled due to the emphasis on rewriting the job descriptions for the staff.

Tim Henkel and Jon Louis have been of tremendous support to me in conducting the business of the Personnel Committee. I give them my appreciation and gratitude for their service.

Westminster Congregational UCC continues to live out the faith of Jesus Christ through justice and action. What is it that WestCAT does and why are they important to Westminster and the city of Spokane?

Well that is simple: over the last few months the Spokane Alliance (and WestCAT as the representative of the church to the Spokane Alliance) has been working on a Statewide Campaign called "Sustainable Works". This is a program that will create green jobs for apprentices and also help make homes and businesses more energy efficient. It is a big project, involving entire neighborhoods in the city of Spokane, but it will make a big difference in the lives of many people and we are proud to be a part of this project. We were active in the second STA campaign to protect the transit system in our city, we were involved in protecting citizens interests with the sale of Empire Health Systems, and a delegation went to Tacoma for the founding assembly of our sister organization, the Sound Alliance. We also received another round of free health screenings this past spring.

Recently, I(Nick CastroLang) attended the IAF (Industrial Areas Foundation) Northwest Regional Institutes where I learned about broad based organizing and what it takes to be a leader in a broad based organization, and how that affects WestCAT and Westminster. It was pretty intense but I learned a lot.

The most recent work WestCAT is doing for Westminster is to help organize and support the "Listening Season Campaign" we will be doing in January and February. In a "Listening Season" we church members talk about the values of the church and how to apply them to the spiritual and the economic future of Westminster. WestCAT is an important tool because through the IAF Organizing principles we have learned that you must attack issues straight on, and get direct results. This may mean a long discerning process of those who are involved, but it must be done in order to preserve the well being, sustainability, and future of this church and its great people. 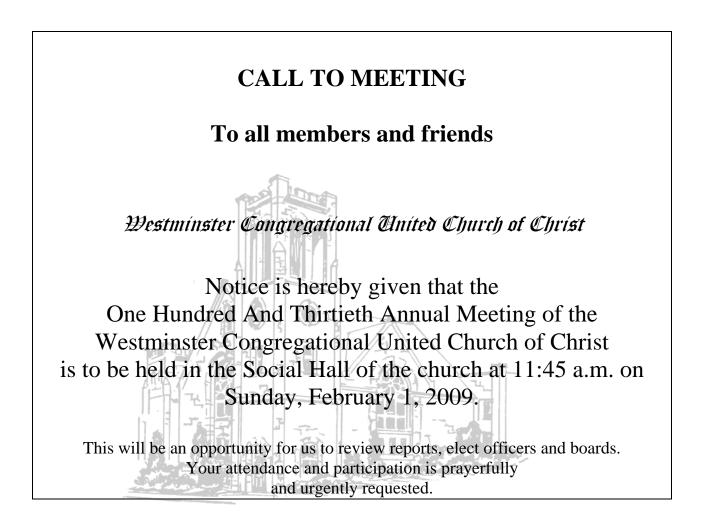
